

## **ATTN: SENIOR CITIZENS TAKE ACTION NOW!**

*Most Senior citizens are concerned about the effects of ObamaCare on their health care coverage. Here are some facts we know, as of now, from the bill which the House recently passed. (Senate debate is set to begin.)*

- Medicare patients will eventually be *assigned to doctors*, who will be paid a fee-for-service. (Sec. 1161)
- Medicare Advantage will be cut for those over age 65. (Sec. 1114)
- Physicians' Assistants will replace doctors in overseeing hospice patients. (Sec. 1114)
- Seniors can pay higher premiums for MediGap from AARP. (AARP supported the bill in exchange for financial benefit).
- A grandfather clause will phase out private insurance by 2013.
- The Health Benefits Advisory Committee will recommend covered benefits. Most members of this committee are appointed by the President. *Medicare already denies more claims (6.85%) than any private insurer.* (We also know that many of Obama's current advisors are self-avowed Marxists/Eugenics advocates.) (Sec. 223)
- The government will have direct access to your bank account for payment of service etc. (Sec 1173A)
- A system for Electronic Health Records (EHR) will be put into effect. The government will have access to your health records. (Sec. 263)
- Voluntary Advance Care Planning will be offered. (Sec. 1233)
